## **President's Message**

Welcome to 2019's 1<sup>st</sup> Newsletter of the year! Not only is this the first "Blueprint" of 2019, but also, it's the first under the leadership of our new Editor, Board Member and Communications Committee Chair, Renee Savickas!

We are looking forward to special NASPCC activities for this 2018-2019 year! With our new Board and with growing numbers of new state prostate cancer organizational involvement in NASPCC we have an even larger critical mass focused on helping prostate cancer patients and their families. Activities that will continue this year will include Quarterly Coalition Conference Calls on topics important to the state coalitions, such as one such Call on Best Practices and one on Step Therapy. These are in addition to our quarterly national Webinars which are free for attendees, have 100 portals, and are archived on our website, www.naspcc.org. We are excited that CancerCare has asked us to once again co-sponsor an ONLINE Prostate Cancer Support Group that is starting up soon. See the Flyer in this Newsletter! Our NASPCC Facebook Page posts articles 2-3 times a week containing updated medical and scientific news we receive even before those articles come out in print. We want everyone to be empowered with information to help in their own informed decision-making. The Newsletter ("The Blueprint") will be produced and distributed quarterly.

**Step Therapy** is now one of NASPCC's Advocacy & Pubic Policy Committee's priorities (and a priority for NASPCC). Our Executive Committee Member Tom Kirk and I will be presenting in a plenary session on Step Therapy at the upcoming 2<sup>nd</sup> Annual AUA Advocacy Summit in Washington, D.C. on March 4, 2019. The Invitational Roundtable is part of our Bone Health Access Initiative that NASPCC is promoting and which is supported by Amgen.

NASPCC plans to attend important 2019 national medical meetings, such as **ASCO GU** (February 2019), **AUA** (May 2019) and **ASCO** (June, 2019) and I will continue to represent NASPCC at the **Early Detection Research Network of the NCI**, on the **UCLA Prostate Cancer SPORE**, and as the **Advocate for the Canary/PASS Active Surveillance Study at Stanford**. I will continue to write quarterly articles for **Prostatepedia** as well.

And, of course, NASPCC continues to make our **Informed Decision-Making Laminate** available as both Awareness and an Educational tool on a nationwide basis. We welcome its use and distribution by all state prostate cancer coalitions and organizations across the U.S., since it helps enable men to make informed decisions about their own healthcare and to be able to have informed discussions with their physicians about their options. Remember that you don't have to be on the Board or even be the official state coalition representative to NASPCC to serve on a Committee.\*\*

We are looking forward to a productive 2019 – to a productive 15<sup>th</sup> year – our Gala Year!!! We started NASPCC in October 2004 and are planning a Gala to coincide with our 15<sup>th</sup> Annual Meeting in 2019, 15 years later. ## Moving Forward on the Bone Health Access Initiative in 2019 By Thomas N. Kirk

In the last Blue Print Quarterly Newsletter of November 2018, you may recall the article about the **Bone Health Access Roundtable** we held on October 14<sup>th</sup> in Washington, DC (page 7). <a href="https://www.naspcc.org/attachments/article/41/NASPCCNewslNov18.pdf">https://www.naspcc.org/attachments/article/41/NASPCCNewslNov18.pdf</a>. This was a major step in NASPCC's Bone Health Access Initiative accepted by the Board's Executive Committee in mid-2018.

We had a group of over 20 people at the Roundtable representing experts and researchers such as Samuel Denmeade, MD from Johns Hopkins Sidney Kimmel Comprehensive Cancer Center, Karl Sjostrand, PhD from Progenics Pharmaceuticals, all the NASPCC Officers and many Board Members, NASPCC State Coalition representatives from active states, Patients and Family Members from the Prostate Cancer Support Community and the Breast Cancer and the Lung Cancer Communities as well as Advocates from other organizations active in the Step Therapy movement, such as the Cancer Support Community's Cancer Policy Institute and the Arthritis Foundation.

Our Goal was to: 1) Discuss the landscape of access to coverage for bone therapies, and 2) Plan appropriate action steps because we have become aware of health insurance policy changes regarding bone therapy access that took place in mid-2018 that will have an effect on prostate cancer patients. We developed an Agenda that covered Step Therapy/"Fail First" Policies that affect access to treatments such as Bone Targeting Agents (BTAs) and shared a number of resources including a "Know Your Rights" brochure created by the Aimed Alliance. <a href="https://aimedalliance.org/wp-content/uploads/2018/08/Know-Your-Rights-Brochure-for-Individuals-with-Cancer.pdf">https://aimedalliance.org/wp-content/uploads/2018/08/Know-Your-Rights-Brochure-for-Individuals-with-Cancer.pdf</a>

You may also recall that Don Lynam, Chair of NASPCC's Advocacy & Public Policy Committee agreed that Step Therapy will be a top priority for our organization as we move forward. Following the Roundtable, we have joined the Aimed Alliance Coalition <a href="https://aimedalliance.org/step-therapy/">https://aimedalliance.org/step-therapy/</a> and the Part B Access for Seniors and Physicians Coalition (ASP) working to address Step Therapy issues at the State and Federal level, and we have signed on to letters written to Federal Officials on proposed changes in Medicare by CMS on Drug Pricing. <a href="http://partbaccess.org/wp-content/uploads/2017/06/12.10.18-ASP-Coalition-letter.pdf">http://partbaccess.org/wp-content/uploads/2017/06/12.10.18-ASP-Coalition-letter.pdf</a>

There is much work to do and part of the **Bone Health Access Initiative** agenda calls for learning what State Prostate Cancer Coalitions are hearing about access challenges, particularly about regarding access to BTAs such as **Xgeva** and **Zometa**. We also need information and stories from patients and family members about their understanding of "value" in bone health treatments. ## **Important Activities Upcoming...**

NASPCC will continue to participate in several important Medical Meetings most of which are held yearly, starting with the **ASCO GU** (GenitoUrinary Malignancies) **Meeting** scheduled for **February 14-16, 2019** in San Francisco. We plan to also attend the **2019 AUA Meeting** (American Urological Association) in May 2019 in Chicago and the **2019 ASCO Meeting** (American Society of Clinical Oncology) in June 2019 in Chicago as well. Of course this does not include NASPCC's invitation to present at a **Plenary Session of the 2<sup>nd</sup> Annual AUA Advocacy Summit** taking place March 4-6 in Washington, D.C. (on the important topic of Step Therapy) nor does it include President Merel Grey-Nissenberg's continued participation in the **NCI's Early Detection Research Network (EDRN)**, in the UCLA Prostate Cancer SPORE (NCI's Specialized Programs of Research Excellence) or as the **Advocate for the Canary/PASS Trial** on Active Surveillance being conducted through Stanford University.

# THE SECOND ANNUAL UROLOGY ADVOCACY SUMMIT TO BE HELD MARCH 4-6, 2019 WASHINGTON, D.C.

NASPCC is excited to announce that the **AUA (American Urological Association)** will be holding a <u>Second Annual Urology Advocacy Summit</u> in **Washington**, **D.C**. from **March 4-6**, **2019** and that NASPCC has been asked to participate in a Plenary Session. (NASPCC President Merel Nissenberg presented on Informed Decision-Making last year at their first ever such Summit.) This year NASPCC will be part of a session on Regulatory Burdens and we will be speaking on Step Therapy, a new Priority for NASPCC since we adopted it as such after the Invitational Roundtable on Step Therapy that we held on October 14, 2018 in Washington, D.C. following our 14<sup>th</sup> Annual Meeting.

The Advocacy Summit gathers together stakeholders from the medical, patient and research communities, and, according to the AUA website, "The conference will host speakers ranging from urologists to patients, to government employees and members of Congress..." Further, participants will be able to meet with lawmakers and their staffs. The keynote speaker is Bob Woodard, who needs no introduction. Lawmakers and other government officials are also expected to attend the Summit. Patients and patient advocates are not only welcome but needed; let's use our critical mass to let Summit attendees and those in Congress know what really matters to patients

### **The Minnesota Prostate Cancer Coalition**

Minnesota Prostate Cancer Coalition was formed in 2011 by prostate cancer survivors, whose mission is to enlighten, educate, support and advocate for MN men, and their caregivers as they face the prospects of diagnosis and treatment of Prostate Cancer.

MnPCC is, grass roots, boots-on-the-ground Organization serving Minnesota.

It is very important to note that all of our Volunteers are living with prostate cancer themselves either as patients or caregivers. This gives us the authenticity and credibility to "walk the walk and talk the talk." We know of what we speak because every day of our lives, we face the fact that we have Cancer. Even when the Cancer may be in some form of "non-expression", all of us men know that we are just one PSA test away from a reoccurrence or the worsening of our condition. Hence we know the emotional pain, fear and uncertainty that accompany a diagnosis of Cancer. Our empathy for our fellow Minnesotans with prostate cancer is real and palpable.

We educate, support and advocate for our constituency by leading two prostate cancer support groups: one at the University of Minnesota and the other at North Memorial Hospital in Robbinsdale, Mn. These two groups put us into direct contact with over 50-75 prostate cancer men and their loved ones every month.

We continue on with our goal of developing a Prostate Cancer Coaching Service for our community.

One of our Board members is certified as a life-coach, having trained at the Mayo Clinic in Rochester. In the future we are hoping to have a permanent, formal space to meet with our men and their caregivers.

Our Coach is also a person living with an aggressive form of PCa and his story and experience are very helpful to guide his assistance to others. We participate in Corporate Wellness Programs and offer information, guidance, support and contacts.
