NASPCC BOD Minutes January 19, 2021 By Merel Nissenberg

The Board of Directors of NASPCC met on Tuesday, January 19, 2021 at 1:00 pm Eastern. Present were: Merel Nissenberg, LaTanya Patton, Jan Marfyak, Tony Minter, Renee Savickas, Paul Kradel, Harold Pharoah, Bruce Williams, Mary Anderson, Dave Hulbert, Crissy Kantor, David Sauls, Robin Leach, Gabe Rosko, Clarence Williamson and Ullyses Wright. Don Lynam was only able to stay on the Call for about a half hour. Tom Kirk attended the Call as Chair of the Steering Committee. The Meeting Call started at 1:00 pm EASTERN. Absent was Stephen Richardson.

Merel Nissenberg gave her **President's Report**. She talked about how COVID has changed our lives, with virtual meetings, cancellation of in-person conferences, etc. She stated that she is optimistic that we will be able to meet in person September 24-26, 2021 to hold our long-delayed 16th Annual Meeting. She touched on PROSTATEPEDIA which she will give a full report on later in the Call. She also touched on our Webinars, which she said she would also address later in the Call.

Jan Marfyak gave the **Secretary's Report**. He presented the full Minutes of the Board of Directors Call held on October 27, 2020 for approval by the Board. No comments or corrections were made, so LaTanya Patton moved, and Renee Savickas seconded to approve the Minutes from the Board Call of 10/27/20. Motion passed. Then there was a review of our Executive Committee Minutes from November, December, January for acceptance by the Board: Bruce Williams moved, LaTanya Patton seconded, Motion passed.

New Treasurer Tony Minter presented the Financials in his Treasurer's Report, which he had sent out to the Board a few days ago. These are for the period of October 1, 2020 (start of our fiscal year) to January 4, 2021. Tony reported that we have (between Checking & Savings) the following: \$ 172,575.14; P & L shows Income of \$ 31,500.59 and expenses of \$38,940.67, for a net Loss of \$7,440.08. Clarence asked Tony Minter to verify his e-mail address; Merel said that she has already written to John Brandt to make sure that Clarence is included in those Listserves. She said she would send the Financials to Clarence after the Call since he had not received them. Gabe Rosko then asked about the \$7,500 payments to Tom Kirk and Merel Nissenberg each for creation, design and production of two (2) Laminates. Merel explained how each Laminate is \$10,000 (each) as listed in our Sponsorship Menu; and that the \$7,500 for Tom Kirk and \$7,500 for her was for the work on both of those 2 Laminates which are for Bayer, including creation, design, meeting and working with experts, and production. She further answered his question as to whether it was pursuant to contract with NASPCC and Merel said that it was (as Independent Contractors) per contract with NASPCC. Jan Marfvak then moved, Ullyses seconded, for approval of the Treasurer's Report. Motion passed.

Website/Facebook Report: Merel reported that John Brandt, our Webmaster, continues to do an excellent job in keeping the www.naspcc.org website current. He recently posted the Webinar of January 11 with Dr. Michael Morris on Theranostics to our website (slides plus recording). He also maintains the Listserves.

There have not been recent postings to the NASPCC Facebook Page. Merel said she will ask Tiffany Razzo, our "Staff" for NASPCC's Webinars and Annual Meetings, who is putting together the DIGEST with Jessica Myers-Schecter after Merel send the articles and abstracts each week, if she can add those to our Facebook Page while adding them to the CPCC Facebook Page as well. Merel strongly urged everyone to check out our outstanding website at www.naspcc.org.

Committees Status Report: Tom Kirk, Chair of the Steering Committee, presented this report which he had sent out to the full Board yesterday. Committees: Communications: Renee has given us the new dates for the new Newsletter (The Blueprint): a February 1 deadline, distribution planned for February 8, 2021. Tom said that the last Newsletter in November was outstanding; Education & Awareness: This Committee continues to meet; its last call was January 13. Next Call is February 10, where we will discuss the Memorandum of Understanding, as well as the various State Coalitions' websites and use of social media. The Committee continues to be chaired by Fran Franklin of the Delaware Prostate Cancer Coalition, assisted by Board Member David Sauls, and Calvin Jackson, among others. Tom then mentioned PROSTATEPEDIA and PROSTATEPEDIA DIGEST; Advocacy & Public Policy: Tom talked about Alvin Chin, the late Chair, whose In Memoriam was highlighted in the last "Blueprint"; he then said that he and Merel had attended the Michigan BIO Advocacy Forum; participated in Friends of Prostate Cancer Coalition calls; they had attended the OVAC Meeting recently, and on December 15, they had participated in a DHRC (Defense Health Research Consortium) Call; and they are planning to attend the DHRC Organizational Meeting on January 29. He stated that NASPCC has also reviewed and signed letters including opposing the Most Favored Nation pricing policy. Tom then said that Alvin Chin who passed away in October had chaired this Committee and we are looking for a new Chair; State Coalitions Development Committee: Rob Johnson Chair, still has not called a meeting of this Committee, although Merel has sent him an e-mail with the list of the current members; Fundraising: Merel continues to do a lot of work in raising funds for NASPCC. This year we are having to file a full 990 because we brought in over \$200,000 in the 2019 Fiscal Year; Annual Meeting: Merel will report on this shortly; it is still scheduled for September 24-26, 2021 in person in Washington, DC.; Medical Advisory: No activity in this Committee which is chaired by Dr. Michael Zaragoza. Budget Committee: Don Lynam headed this up before and we need to have a new Chair, although Don had said that he would help. Tom reminded the Board that the Newsletter lists who is on each Committee. He invited everyone to join or participate in any of the Committees.

IN MEMORIAM for Alvin Chin: Merel reported that she, Tom Kirk, Don Lynam and LaTanya Patton attended a virtual ZOOM Memorial for Alvin on December 17. Merel presented to the assembled ZOOM group, and she has committed to do a Memorial Award in Alvin's name at our in-person 16th Annual Meeting. She told the Board that the Burke, Virginia Volunteer Fire Dept, to which Alvin Chin had belonged, had generously donated \$250 to NASPCC in Alvin Chin's name. Merel described all of the wonderful things that Alvin had done that few, if any, of us knew about, and said we should all be conscious of each other and supportive.

Merel presented next on our **Webinars**. She stated that we had increased our number of free portals to 500. Our last Webinar was January 11 on Theranostics, presented by Dr. Michael Morris of Sloan-Kettering. Our next Webinar is on "Immuno-Oncology and New Mechanisms of Action in Prostate Cancer," to be presented by Dr. Saul Priceman of City of Hope. Merel is working on having Dr. Eric Klein and Dr. Jonathan Epstein do the next Webinars. She reminded everyone that all Webinars are archived on our website, both the recordings and slides.

Merel reported on our **PROSTATEPEDIA** Magazine and our weekly PROSTATEPEDIA DIGESTS. Last Issue of the Magazine was November 2020 on "Immuno-Oncology & PARP Inhibition". The DIGEST is e-mailed out to the large subscription list every Friday and contains links to abstracts, articles etc., and has a free subscription line to sign up. There are also Banner Ads in the DIGEST and full pages of ads in the Magazine. Next Issue: March 15 on "TESTING". Jessica Myers-Schecter is already starting to do interviews that Merel has arranged with outstanding people. Gabe Rosko said he found the DIGEST to be confusing and suggested that we show the dates for each article in the DIGEST, because it seems like we are repeating the articles; and he also said it's hard for him to see the print when he prints it out. He suggested it be more user-friendly. Merel said she would speak with Jessica Myers-Schecter, our Editor. Ullyses asked if people can subscribe by just going to our www.naspcc.org website. Merel said yes.

Merel reported that the **Annual Meeting** is on track for September 24-26, 2021 at the Hotel Monaco in Washington, DC. We are taking nominations for the Awards that we give out – such as the James West Spirited Advocate Award and an award for Outstanding Physician and an Award in honor of Alvin Chin.

Merel stated that the next **Board Meetings** are in April and July, on April 20, 2021 and July 20, 2021. They are always at 1:00 pm EASTERN. Mary asked when is it safe to buy our tickets, and Merel said probably not until June or July. We will add this to the April and July Board Meeting Agendas.

Bruce Williams then asked if there was any funding that resulted from the December 16 GIVING BACK Supplement to the LA Times that we had paid for. Merel said not that she can show, but that it definitely increased our visibility since it was delivered to 100,000 households. She stated that the Supplement was in magazine form and that we had a full page "advertorial" with our website, our most important activities and resources, etc. Tom then added that he agreed about increasing our visibility, and complimented Merel on her fundraising, stating that we had budgeted to raise \$152,000 last year but that Merel had raised \$250,000, and that he thought she had done a great job. Ullyses said that she was an "expert" at fundraising. Merel then added to the conversation stating that NASPCC had been participating in certain activities where we were the only invited group, such as the CURE Magazine's Educated Prostate Cancer Patient Summit last Fall, where for prostate cancer groups it was only NASPCC and PCF. She also mentioned again that there is a limited "pot", and all of the prostate cancer groups are going after the same "pot", so there is a lot of competition to raise funds.

There being no other business, the Board of Directors Meeting adjourned at 1:58 pm EASTERN.

Update on NASPCC Committees

Since the last NASPCC Board Call on January 19, 2021 (and the previous one on October 27, 2020), the NASPCC Committee activities have been updated at each of the Monthly Executive Committee calls (November 10th, December 1st, January 5th and February 2nd). We want to Thank everyone who is involved in the work of the Committees and urge others to join us. It really is rewarding!

- 1) For the **Communication's Committee**, Committee Chair and The Blueprint Newsletter Editor Renee Savickas has completed Volume 3, Issue 3 of the **Blueprint** in November and it is posted on the NASPCC website. This Committee Update is prepared for February 2021 Issue of the Blueprint.
- 2) Rob Johnson has called a meeting of the **State Coalition Development Committee** on Tuesday February 9th.
- 3) Calvin Jackson chaired the **Education and Awareness Committee** meeting for Fran Franklin on Wednesday January 13th. Tom Kirk prepared the Minutes from the January 13th call again and the next call is set for Wednesday February 10th. Potential Agenda items include a review of the Draft MoU and the survey Grid on the State Representatives' Social Media sites. The Committee usually keeps the NASPCC Webinars on its Agenda. The Webinar held on January 11th on the topic of "Theranostics in Prostate Cancer" and was presented by Dr. Michael Morris Memorial Sloan-Kettering Cancer Center was well received. The most recent Webinar on Monday February 1st on the topic of "Immuno-Oncology: Novel Mechanisms of Action in Prostate Cancer" with Saul Priceman, PhD, Assistant Professor, Department of Hematology & Hematopoietic Cell Transplantation at City of Hope was also well-received. The next Webinar featuring Dr. Ashley Ross, Associate Professor, Northwestern Feinberg School of Medicine in Chicago, is titled "Use of Genomics to Guide Decisions after Radical Prostatectomy" and is set for March 10, 2021.

Merel continues to be active with Jessica and Tiffany to roll out the next issues of Prostatepedia and the weekly Digest. The November issue Volume 6, Number 2 on Immuno-Oncology and PARP Inhibition was released on November 13th. The next issue is targeted for March on Testing. The most recent weekly Digest issues were sent on January 22nd, January 29th and February 5th with minor edits to make the Digest content more manageable based on comments made during the January 19th NASPCC Board Meeting call.

Merel and I represented NASPCC at the virtual Patient Advocacy Forum sponsored by MIBio on December 14th. We continued to be involved in the Friends of Prostate Cancer Care Community (FoPCCC), the latest call was held on December 15th.

Merel and I held a follow-up call with their staff on Wednesday January 13th and have received a series of new weekly emails/Newsletters from their staff, the most recent one received on February 3rd. They are attempting to highlight events of participating organizations. Mark Veith has kept us up-to-date on the DHRP and Merel and I were on the December 15th call with the new program head, Col. Sara Goldman and key staff. Merel and I also attended the DHRC Virtual Annual Organizational Meeting call on Friday January 29th. Mark is targeting visits for Staff Committee Clerks during the week of February 15th.

NASPCC also signed onto several letters on issues such as United Health Care's (UHC) Accumulator Adjustment Medical Program Provider Protocol and Most Favored Status (MFS) initiative by Medicare.



Public Policy/Advocacy areas we are following: 1) NCCS sent the January 15th Health Care Roundup which covered COVID-19 Updates and other future NCCS agenda issues, 2) Aimed Alliance sent the Volume 2, Issue 12 update on December 31st and the Volume 3, Issue 1 sent on January 30th.

5 and 6) Merel continues to head the **Fundraising Committee**, no recent meetings held, but she shared she has a copy of the LA Times impressive magazine-like Giving issue during the Board meeting call which featured information on NASPCC. For the **Annual Meeting Committee**, she has been in contact with the Hotel Monaco staff for the September 24-26, 2021 date.

7 and 8) Don Lynam assured us that he will help with the **Budget Committee** when the Committee becomes active, but we will need a new Chairman to replace him. We have been working with Don, Tony Minter and AJ Sharpe from Hicks & Associates to review the Draft of the NASPCC Federal and CA State Tax Forms for FY 2019-2020 which are due mid-February. The Federal 990 will be sent electronically and Don and Tony will sign the CA forms, cut checks and get mailed. Tony Minter has replaced Johnny Payne as the South Carolina State Representative and has replaced Don as the NASPCC Treasurer. Don moved to serve as Director-at-Large on the Executive Committee and LaTanya has moved to Vice-Chairman of NASPCC, replacing Johnny Payne. And finally, Michael Zaragoza continues to Chair the **Medical Advisory Committee** and Merel recently heard from Dr. Saul Priceman that he accepted the invitation to serve on the NASPCC Medical Advisory Committee.

BECOMING INFORMED AND AWARE

MORE AND AWAKE

More and more of us are learning more and more about cancer, but even with rapid changes in oncology, much remains unknown. Although prostate cancer is a common cancer, many people do not know about it. Some people are more at risk than others. Every man should have a discussion with his doctor about prostate cancer risk and testing. After that discussion, the decision to be tested is then up to the man based upon his own values and preferences. This is called INFORMED OR SHARED DECISION-MAKING. We have adopted a 2-sided useful tool on Informed Decisiona 2-sided useful tool on Informed Decision-Making to take to your doctor's office to help you with the discussion. NASPCC recommends a baseline PSA and DRE beginning at 40 (at 35 if high risk, including African-American men or men with a certain or indeterminate family history of prostate cancer), and then periodically depending on those results. You should know and keep track of all your PSA measurements and ANY CHANGE IN PSA should be discussed with vour doctor.



EARLY STAGE AND ADVANCED DISEASE

In early stage prostate cancer the disease is still inside of the prostate and has not spread beyond the gland. This is the most treatable stage. In advanced prostate cancer, the disease has spread outside of the prostate to adjacent areas, or has spread to non-adjacent areas through metastasis (where the disease has traveled by blood or lymph nodes away from the prostate and has formed new tumors elsewhere in the body). The goal is to diagnose prostate cancer in its early stages. The earlier prostate cancer in its early stages. The earlier prostate cancer is detected, the more options a man has for treatment and almost always the better the outcome. If found early, the 5-year survival rate is nearly 100%.



TREATMENT FOR PROSTATE CANCER

In early stage prostate cancer, In early stage prostate cancer, Active Surveillance, Surgery, and Radiation Therapy are the standard choices for reatment. Active Surveillance is gaining in popularity for clinically insignificant prostate cancer since it helps avoids overtreatment. For advanced prostate cancer, treatment choices include Hormone Therapy. Chemotherapy Immunotherapy Therapy, Chemotherapy, Immunotherapy and Radiation Therapy. Most treatments for prostate cancer involve a risk of side effects. . Clinical trials may be an option.
